The Salvation Army has been involved in long-term care in Canada since 1926. Our tradition of service in Ottawa dates back even further. The Salvation Army has been providing healthcare to the people of Ottawa since 1904 when the first home for unwed mothers was opened on Daly Avenue.

In 1922 the Grace Hospital was built on Wellington Street. When the hospital closed, the Grace Manor was built on the site and opened in September of 2002.
